NATURE CONSERVANCY, ARCHEOLOGICAL CONSERVANCY, AMERICAN FARMLANDS TRUST, and THE TRUST FOR PUBLIC LANDS are all useful sources of information and advice and do from time to time on a per-case basis put up funds for the acquisition and preservation of wetlands, natural areas, historical sites, etc.

The Trust for Public Lands has the biggest purse — over \$250 million to dip into for purposes in line with their overall objective. They typically buy or finance a large land purchase, let 5% of it be developed under their supervision, as a means or getting some money back, and preserve the remaining 95% in the state of nature. I don't know whether their operation would be helpful in our case, but the information would be good to have.

.. Steven Stillwell, City Manager for Elk Rapids, has recent and current information on the availablity of grant money, stemming from Elk Rapids' recent nogotiations regarding their marina and harbor. I believe he has in particular some up-to-date information on one of the DNR grant categories that is being revised at the moment, but will be on line on February 1, with an April 1 deadline. He is also the source of this practical advice:

When the applicant's minimum matching money is set at a given percentage, like 25%, it is wise to offer something a bit better, like 30%, so as to edge out other applicants who tend to stick to the bare minimum figure.

.. Finally, there is a bulletin available, and very likely the advice of its author, on projecting the operation and upkeep costs of municipal parks. It is known by the number E 1252, File 36.44, and is available through the Extension Service.
